Terms & Conditions:

1. The incumbent will be paid a lump sum consolidated remuneration of ₹ 25,000/- (**Rupees Twenty-Five Thousand**) only per month and additionally a maximum of Rs 15000/- (Fifteen thousand) only for performance linked incentives subjected to monthly indicator performance.
2. **The place of posting will be at the identified District SC-HWC. For final posting, district may post the respective staff as required.**
3. The post is transferable subjected to availability of vacancy and completion of minimum of 3(Three) years of service.
4. Leave policy as per HR-NHM Policy will be effective on completion of 1 (one) year of service under NHM.
